

## 2019 Managed Care Seminar Creating a Myopia Management Practice Focus: Best Practices to Adopt

I am writing in my capacity as chairman of the New Jersey Society of Optometric Physicians' Third Party Center committee and chairman of our Managed Care Seminar organizing committee.
