Dr. Daniel Epshtein will share how he uses OCT in the identification and management of a variety of ocular diseases and Dr. Bill Ceraso will speak about the transformation of his practice to reduce his reliance on vision care plans and create a very loyal patient base.

We expect an audience of 125 ODs and staff from the tri-state region. I think that you will find these doctors to be receptive to information about your products in a smaller exhibit space which allows more direct contact with the attendees during the breakfast, mid-morning break, and lunch.
